#### LEAGUE RULES

1. **NAME.** The amalgamation of clubs shall be called the Mid-Northants Village Cricket League.

2. **FUNDS.** The Annual Subscription shall be £1, to be paid before the commencement of the season. Any deficiency at the end of the season to be shared equally by all clubs.

3. **OFFICERS and MANAGEMENT.** The officers of this league shall consist of the President, Vice-Presidents, Chairman, Hon. Secretary, Fixture Secretary, Hon. Treasurer, and a management committee comprised of two representatives from each club. The Secretary shall convene meetings at any time he may deem necessary and at the request of any club shall call a special meeting.

4. **POWERS OF COMMITTEE.** All questions of eligibility, disqualification of clubs, interpretation of rules, or any question in dispute not provided for by these rules (except as to play) shall be referred to the Management Committee, whose decision shall be final. No member of the Committee shall vote on any dispute arising in connection with his own club.

5. **POINTS.** Four points to be awarded for a win, two for a tie, and two for a draw.

6. **CANCELLED MATCHES.** Matches cancelled by clubs for any reason other than weather conditions, the club in default to forfeit four points to opponents. Matches cancelled by weather to be deemed a draw—each club taking two points.

7. **FIXTURES.** All fixtures to be arranged

prior to the commencement of the season by the Fixture Secretary.

8. **SCORERS and UMPIRES.** Each club to provide own scorer and umpire if possible for each match. If no official is available, the captains to nominate same from batting side.

9. **RESULTS.** The secretaries of home clubs to notify the Fixture Secretary the result of the match by the Tuesday following the Saturday on which the match was played. Result sheets must be completed in full.

10. **HOURS OF PLAY.** All matches to commence at 3.00 p.m. with a maximum of three and a half hours play exclusive of tea interval. Either side may claim an extra 15 minutes if necessary.

11. **REGISTRATION OF PLAYERS.** Each club to submit list of all club members to the Fixture Secretary prior to the commencement of the season, and any additions during the season.

12. **LEAGUE TROPHY.** The Chairman, Hon. Secretary and Hon. Treasurer to be Trustees of the League Cup, which will be insured for its full value by the League.

13. **ANNUAL GENERAL MEETING.** The Annual General Meeting to be held during the month of November.

14. **ALTERATION OF RULES.** The foregoing rules may not be altered without the consent of a General Meeting.

#### TO CLUB SECRETARIES

Ensure that your club is represented at all

League Meetings. Secretaries of clubs only are notified of meetings, and where necessary they must themselves notify their elected representatives. Do all you can to advertise the league, especially through the local press.
