

RULES

1. Title
The name of the Club shall be "The Kettering and District General Hospital Social Club".
2. Address
The address of the Club shall be General Hospital, Rothwell Road, Kettering, Northants.
3. Objects
The objects of the Club shall be to establish, foster and co-ordinate the social, physical and recreational activities of its members and associate members.
4. Eligibility for Membership
 - (a) Full Membership
All employees of the Kettering and District Hospital Management Committee shall be eligible for membership of the Club.
 - (b) Associate Membership
Associate membership shall be extended to members of the Hospital Management Committee, House Committees, and Oxford Regional Hospital Board employees working in the Kettering Group of Hospitals.
 - (c) Honorary Membership
Club members who retire from their employment with the Kettering and District Hospital Management Committee shall at the discretion of the General Committee be eligible for transfer to honorary membership.
5. Membership
All persons eligible for membership in accordance with para. 4. shall be sent a written invitation to become members, and on completion of the official application form and having paid any subscriptions due, shall be deemed to be members of the Club.
The General Committee shall have the power to terminate membership.

6. Subscriptions payment and financial year

The annual subscription for members shall be 1s. 0d. (Associate Members 2s. 6d.) payable in advance. (The subscription and financial year shall be from April to the following March).

7. Arrears of Subscription

A member whose subscription for the new subscription year has not been paid by 31st May, in any year, shall, if payment has still not been made on the expiry of seven days after receiving a reminder letter from the Treasurer, and, unless he gives notice of resignation, remain a member of the Club, liable for subscriptions as they fall due, but shall be precluded from participation in any activity of the Club until all sums due from him to the Club be paid.

8. Election of Officers

The following officers of the Club shall be elected at the Annual General Meeting :-

- Chairman
- Vice-Chairman
- Secretary.
- Treasurer
- Two Auditors

Nominations for these offices proposed by two members must be received by the Secretary in writing, at least 14 days before the Annual General Meeting. The Auditor's need not be members of the Club.

If more than one nomination is made for any office, a ballot shall be taken at the Annual General Meeting and each member of the Club present shall be entitled to one vote in respect of each office to be filled.

9. Election of Staff Representatives

The following staff representatives shall be elected, by ballot if necessary, of all members present and voting at the Annual General Meeting :-

- ONE - Junior Medical Officer
- TWO - Sisters
- TWO - Staff Nurses
- TWO - Student Nurses
- TWO - Nursing Auxiliaries
- TWO - Nursing Cadets
- TWO - Professional and Technical Staff
- FOUR - Ancillary Staff (2 Female - 2 Male)
- TWO - Administrative and Clerical Staff
